In the past, instances have come to notice where some students of medical colleges were found to be involved in activities that could compromise the sanctity and integrity of the examination process. In view of this, and as a matter of general deterrence, all the medical colleges are hereby directed to remain vigilant and ensure that students are sensitized against any involvement in activities prejudicial to the conduct of the examination.

3. Further, all the medical colleges are advised not to grant leave to students on 20th June and 21st June, 2026, except in exceptional circumstances with due justification. This measure is intended as a preventive step to discourage any potential misuse and to support the fair conduct of the examination.
